Bibliography and Objectives

This four-day seminar will discuss the EU's role in the context of human rights. It will look in detail at the main European inter-governmental organisations regarding human rights: The Council of Europe (CoE) and the European Union (EU). The focus will be both on the internal European human rights systems, but also their cooperation and external EU policies. The workshop invites the participants to learn about the European institutions and the tools developed to promote democracy and protect human rights. Drawing on these essentials the participants will also be challenged to assess the EU's position critically and gain practical insights through case studies. Groupwork and the interactive approach of the seminar will enable diverse discussions and learning from each other's experiences and different point of views. The main objective is to gain a better understanding of the European human rights system and to discuss current and future human rights challenges in this regard.

What is the rule of law?

The rule of law is enshrined in Article 2 of the Treaty on European Union as one of the founding values of the Union. Under the rule of law, all public powers always act within the constraints set out by law, in accordance with the values of democracy and fundamental rights, and under the control of independent and impartial courts. The rule of law includes, among others, principles such as legality, implying a transparent, accountable, democratic and pluralistic process for enacting laws; legal certainty; prohibiting the arbitrary exercise of executive power; effective judicial protection by independent and impartial courts, effective judicial review including respect for fundamental rights; separation of powers; and equality before the law. These principles have been recognised by the European Court of Justice and the European Court of Human Rights.
